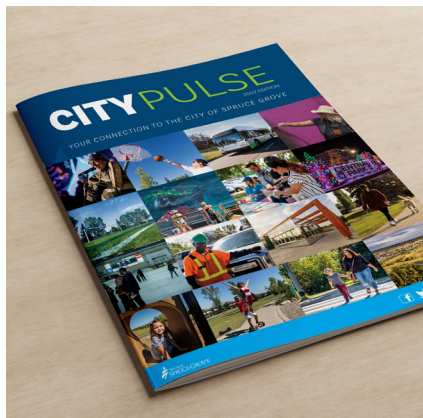

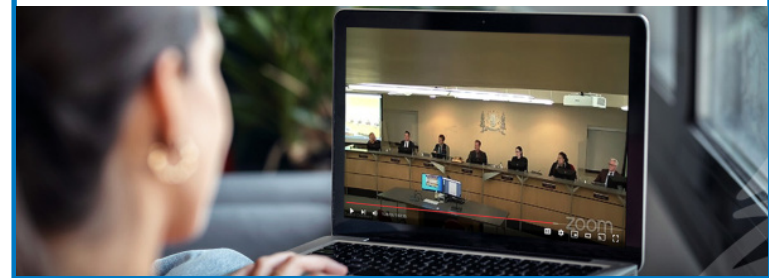
## Regular Council meeting
