#### **Important information for cat owners**

As pet owners, we have a responsibility to care for our pets, while also being considerate of our neighbours and the community.

To bring clarity to the regulations around pet ownership in Spruce Grove and ensure the safety and well-bring of residents, pets, and pet owners, the City's Dog and Domestic Animal Control Bylaw has been reviewed and updated. It is now called the Responsible Pet Ownership Bylaw.

Under the updated bylaw, cat owners are required to regulate the behaviour of their pets in a manner consistent with that of dogs, including:

- They are not permitted to run at large.
- They must wear a collar with ID tag containing the owner's phone number.
- They must not cause a public nuisance.

### New speed limits for residential neighbourhoods


Spruce Grove is committed to improving traffic safety and creating safe, sustainable roads and quiet, peaceful neighbourhoods for all residents. To support this, speed limits in residential neighbourhoods will be reduced from 50 km/h to 40 km/h, starting August 31, 2024.


